It formulates and approves policies and organizational systems and evaluates the overall performance of **AMU** Foundation on a period basis. The BoT consists of five members (both male and female) and is headed by its Chairperson. The Foundation's board of trustees comprises of development professionals, intellectuals, financial experts, and academicians, activists/advocates and media persons. The Executive Director of **AMU** Foundation serves the board as the secretary and ex-officio member. The Board works in the guidelines of the Board Policies Manual.

13. MANAGEMENT

AMU Foundation is led by its Executive Director who is the formal head of the organization. The Executive Director reports to the Chairperson of the Board of Trustees (BoT) and is responsible for the overall management of the foundation.

The Executive Director is supported by the management programs and team of coordinators /managers of different sections/programs of the foundation and they jointly form a management structure for the Foundation.
